

**PALO ALTO COUNTY SECONDARY ROAD DEPARTMENT
TILE AND/OR WATER LINE CROSSING PERMIT AND AGREEMENT**

Palo Alto County, State of Iowa and _____
(hereinafter referred to as property owner) do hereby enter into the following permit and agreement:

1. Palo Alto County hereby consents to and grants permission to the property owner to place a Tile/Water line across the County Right-of-Way. (See plat for location and description)
2. In consideration of Palo Alto County granting said permission and consent, the property owner hereby promises and agrees to the following:
 - A. The line is to be placed a minimum of 3 feet below the existing waterway.
 - B. The property owner, at his own expense, and with the approval of the County Secondary Road Department, will provide all safety measures, warning devices, and advance signing necessary to protect the traveling public during construction.
 - C. If closing of the County Road is required to accomplish the crossing, the contractor or property owner shall notify the Secondary Road Department at least two (2) working days prior to any closing. The road will be closed only as long as necessary to complete the crossing. No crossing will be left open at night without approval from the Secondary Road Department.
 - D. No permanent roadway surface or pavement will be cut or disturbed in any manner without written approval from the County Engineer.
 - E. The contractor or property owner will restore, at his own expense, the roadway surface to its original condition on all crossings except field tiles as approved by the Secondary Road Department.
 - F. It shall be the responsibility of the property owner, authorized representative, or his contractor to notify Iowa One-Call (1-800-292-8989) and utility companies at least two (2) working days in advance of any excavation.
 - G. PROPERTY OWNER HEREBY AGREES TO SAVE HARMLESS AND INDEMNIFY PALO ALTO COUNTY AGAINST ANY AND ALL CLAIMS FOR DAMAGES FOR PERSONAL INJURY OR PROPERTY DAMAGE ARISING OUT OF WORK PERFORMED OR ACTIONS TAKEN BY PROPERTY OWNER OR AUTHORIZED REPRESENTATIVE PURSUANT TO THIS AGREEMENT.
 - H. NOT CONFORMING TO OR ACQUIRING THIS PERMIT IS A VIOLATION OF SECTION 319.14 1991 CODE OF IOWA.
